Throughout the program students will observe an infant (0-12 month(s) starting, and the earliest is best, i.e., 0 to 1 month) and their parent(s)/family system in the home for 30 to 60 minutes several times during each term. Students are advised to identify an appropriate family for this observation prior to the start of the first course in this program.

Review for admission to the CIECMHC program is contingent on:

- 1) Supplying all requested application documentation to Troy University for admission to the Graduate School and the CIECMHC.
- 2) Passing a fingerprint background check.

Scholarships for CIECMHC through Troy University

The *Certificate in Infant and Early Childhood Mental Health Counseling* program has a limited number of scholarships each year to award to qualified applicants.
